Approximately \$1.7 Billion in New U.S. Direct Lending Commitments Closed in the Second Quarter and Approximately \$4.4 Billion in the Year-to-Date Period

LOS ANGELES--(BUSINESS WIRE)-- Ares Management Corporation (NYSE: ARES) is providing details on certain new financing commitments made across its U.S. direct lending strategies. Funds managed by Ares Management Corporation's Credit Group (collectively "Ares") closed approximately \$1.7 billion in commitments across 24 transactions during the second quarter and approximately \$4.4 billion in commitments across 64 transactions in the year-to-date period.
