# Ares Management Corporation Leads A\$280 Million in Credit Facilities to Waste Services Group in First Sustainability Linked Private Credit Financing in Australia

The transaction marks the first financing led by Ares' Australian Direct Lending team and is also the first private credit-backed sustainability linked financing in the Australian market. The new credit facilities include a sustainability linked margin ratchet, whereby the interest rate payable is directly correlated to the Company achieving certain pre-determined performance targets. These targets will be aligned to the Company's long-term strategy to support the development of greener and more sustainable waste solutions in Australia.

"We are excited to serve as the sole lender for this inaugural sustainability linked financing in the Australian market and to grow our longstanding relationship with the Livingbridge team," said Peter Graf, Managing Director in the Ares SSG Group. "We remain committed to partnering with sponsors and companies to drive forward a collective ESG vision in the markets and communities in which we operate."
